INTRODUCTION

SHEIKH TIHAMI IBRAHIM NYASS FOUNDATION

Sheikh Tihami Ibrahim Nyass Foundation conscious of the desire to contribute in the development of The Gambia, appreciating the need to contribute individually, and collectively in a participatory manner, to improving the quality of life of all Gambians and being aware of the need to establish a viable organization in order to promote greater participation and involvement in the development of The Gambia.

Sheikh Tihami Ibrahim Nyass Foundation is a charitable, non-profit making, non-political and non-religious organization, that seeks to promote culture and development in The Gambia.

ARTICLE 1: NAME

The name of the organization shall be Sheikh Tihami Ibrahim Nyass Foundation.

ARTICLE 2: AIMS AND AOBJECTIVES

1. To promote sustainable development in The Gambia through agriculture environmental sanitation, health and education.
2. To enhance the capacity and performance of communities, Katos in their development aspirations.
3. To contribute towards poverty reduction by networking information sharing.
4. To promote environmental protection and desertification trends.
5. Promote microfinance, Good Governance.
6. To install in young people the virtues and values of honesty, truthfulness, compassion, obedience, love and struggle and integrity of scholarly life.

ARTICLE 3: CO-OPTED MEMBER

Co-opted members are obliged to accept the rules, procedures and regulations of the organization.

ARTICLE 4: FUNDING AND FUNDRAISING

Funding of the organization shall come from the following sources:

1. Financing from individual members.
2. Money realized from, due ...
3. Money sourced locally from benevolent individuals, NGO' s ...
4. Money sourced internationally through donations from international organizations and companies
5. Preparation of project proposals and marketing them to potential donors.

ARTICLE 5: FINANCE AND FINANCIAL MANAGEMENT

1. All money acquired for Sheikh Tihami Ibrahim Nyass Foundation shall be used forwards realizing the aims and objectives of the organization in The Gambia.
2. The organization shall open account in any Bank approved by the Executive Committee Into which all funds of the organization shall be deposited.
3. The organization shall be audited once a year by a competent auditor.
4. An audited statement of account for the previous year shall be submitted to the Executive Committee.
5. The President, Secretary, and Treasurer shall be signatories to the organization' s Bank accounts.

ARTICLE 6: OFFICERS

The officers of Sheikh Tihami Ibrahim Nyass Foundation shall be as follows:

1. President
2. Secretary
3. Treasurer
4. Adviser
5. Members (7)

ARTICLE 7: FUNCTIONS OF OFFICERS

THE PRESIDENT

1. Shall be the executive head of the Association.
2. Shall chair all meetings and shall serve as focal person for the organization.
3. Shall represent the organization at outside engagement and negotiations.
4. Shall be signatory to all-important documents of the organization including finance.

THE SECRETARY

1. Shall be responsible for keeping of the organization records.
2. Shall be responsible for the recording of financial transactions.
3. Shall be responsible for all recording of minutes of meetings.
4. Shall serve as the Public Relation Officer of the organization.

THE TREASURER

1. Shall be responsible for the preparation of the annual budget of the organization.
2. Shall be responsible for the safe keeping of all the organization funds.
3. Shall be responsible of collection of dues, fees or other monetary instrument on behalf of the organization.
4. Shall receive or make payment and manage the funds of the organization.

THE ADVISER







1. Shall advice on all matters affecting the organization.
